My dear Brother Finley

I hope you will forgive the liberty I take in addressing you again. I only wish to say I have just finished my last round on the Circuit & I am more than ever convinced that I ought to be returned Bro. McFarland one of the class leaders at Brownsville who possesses perhaps a little more common sense than any man on the Circuit says he thinks if I am not returned and the present Administration carried out it will be a great disadvantage to the Church on this Circuit that if I should be sent to another Circuit my successor on this one would in all probability undo what I have done or at least not carry out the present Administration which he thinks would be a great drawback on the prosperity of the Circuit. Brownsville and the little Clay lick are going to send up written Petitions for my return when I heard it I protested against it I told them it always looked to me too much like Radicalism
