Harrisville Apr 16th 1839

Dr Bro

This morning I rec^d yours of the 11th Inst. was glad to hear from, but sorry about that troublesome not to say interminable case of Elliott & Latta.

So far from your account Bellows has acquitted himself (in this case) well.

Now I understand this Elliott case to be in the hands of the Bishop & Conference & that you (officially) have nothing to do with it on your District. This was one of the principal objects I had in view when drawing up the Resolutions referred to in your letter—reproached as you had already been I thought, you were not the person to settle the difficulty. You can have nothing to do with Elliott unless some new matter should occur, and even then if I were in your place I should do nothing till the Bishop & Conference had settled the old affair! So I counsel J. W. Finley.

Then as it respects Latta—there being no charge or charges against him—he cannot take testimony to rebut nothing! He has in his possession the recantation of Elliott which (to say the least) will forever be an inalienable draw back on his veracity & integrity. It is right for a man to be prudent. Latta should forget nothing—he ought to learn all he can in this case in which he is deeply interested. But let him act wholly on the defensive—acting otherwise in the other case you see produced the Bishops protest, & it is to be feared has cost the Committee a good deal of their well earned character & standing. Prudence says this is dangerous ground to stand on.
